All I do remember is falling on the driveway and not being able to pull myself up. I awoke the next morning in bed. My knees and toes were covered with raw places where I must have tried to crawl to get either inside the car or garage.

I didn't wake up with a terrific hangover. I did have, however, the feeling that had God not been my copilot that night, I never would have made it home. It is amazing that I didn't hit something or someone, or that the guard at the gatehouse would not have noticed my condition and called the police.

My thoughts that morning were that last night absolutely had to be my last drunk. I didn't think, however, that I might be an alcoholic. I just had a few too many. Someone else in my household didn't agree, and three days later I was the subject of an intervention. I saw a counselor, but didn't really have my heart in it.

Three weeks later, I agreed to attend an A.A. meeting. I entered the room thinking I might not stay the full hour, but within 30 minutes I knew I was in the right place, and that, yes, I was an alcoholic, that I was powerless over alcohol and that my life had become unmanageable.


Eleven years have gone by, and I am still in a state of bliss. Thank you A.A. and all of my fellow A.A.ers for making my life worth living again.



The next attempt, Monday, May 20, C. was in place, the meeting started, the topic was "newcomers," but there was no mention of J. or Skype or anything techno. But at the end of the meeting C. showed the screen on his phone and there was J., in his signature Oxford shirt saying hi to all of us. We could not have ripped the grin from his face. Happy ending.

However, fast forward a couple of weeks to our regular monthly business meeting, when group members who had not been present at the "mini" meeting, expressed alarm at the blatant violation of Tradition 11, and the threat to group members' anonymity. Fear, that evil and corrosive thread, divided the group conscience. An ad hoc committee was formed and charged with contacting GSO in search of guidelines for handling this new technology of communication. Pending the delivery of that information, the group will vote on whether to continue Skyping J. into his home group meetings. Stay tuned.

The gossip protested that it would be impossible: he could not find the bits of down in a lifetime: many of them had blown far away.


"So it is with gossip," replied the priest. "It is easily dropped. But never again, no matter how hard you try, can you gather back the words you have so thoughtlessly scattered."
