Interview with a Longtimer

What is your name? Jim M.

What is your sobriety date? January 31, 1964

In what City or Town did you first get sober?

Cleveland, Ohio. My first meeting was at Charity Hospital on a Friday Night. I was 25. It was a speaker meeting. Sister Ignatia had a sober ward called Rosary Hall at the hospital. Initially, it was men only. She had a policy allowing AA members to come and visit patients at Rosary Hall, but she didn't allow family members or anyone from the courts to come. Most of the speaker meetings were open meetings.

What was the name of your first home group?

Lakewood Armory. It was a speaker meeting. Ninety-five percent of the meetings in Cleveland in those days were speaker meetings.

What were meetings like when you first got sober?

All smoking meetings, even in the hospital!

How long did it take before you got a sponsor?

I met my sponsor on the first night of my first meeting. Jimmy M was my first sponsor.

Did you stay after your first meeting or did you go out and do more research?

I stayed sober from the first meeting I attended.

When did you move to Florida?

I moved here in 1998.

What was it like to make the adjustment to going to meetings after you moved?

I had some friends here when I moved. I also met a lot of people at Roy's Palm who met on the beach every morning.

Is AA and the 12-Step world different now than it was then?

I don't think there is anything different about the the literature or the institution. There were a lot fewer women when I came into AA, so that has changed. Also,

the format of the meetings has broadened. No smoking meetings were a big change. For insurance purposes, most churches did not want smoking at the meetings. Most of the meetings now are closed meetings except for speaker meetings.

What other big changes have you seen in AA since you got sober?

There are a lot more meetings. All of the meetings are non-smoking. There are more women in AA. People are coming in at a younger age. However, the message is basically the same. Another big difference is that we used to get a lot of requests for 12 step calls. Now, many people are coming in from the courts, police departments, detox, or inpatients treatment centers.


Is there anything else you'd like to share?

I am a Convention Junkie. My first AA International Convention was at the Maple Leaf Gardens in Toronto, Canada. That was in 1965 and Bill Wilson was one of the main speakers.

Early Recovery

ON DECEMBER 5, 1999, my stepmother dropped me off to my first meeting of Alcoholics Anonymous. I was out on bail. I was scared and a very confused 23-year-old adult child. I did not know what direction my life was headed. All I knew was, it was not going in the right direction. I was listening to everyone who shared in the meeting. My mind was just racing.

After the meeting was over, we stood up and held hands and recited the Lord's Prayer. Holding the men's hands to my left and right, I felt a connection that I never felt before. For the first time I can remember, I felt safe. I knew Alcoholics Anonymous was where I belonged.

A week later, I went to a young people's meeting. There were people there of all ages. I felt the urge to share what brought me into the rooms. When I did that, it was like a huge weight lifted off my shoulders. People started sharing their experiences and what brought them into the rooms. I could really identify and relate to what they were saying.

Out of all the people that shared, there was one gentleman that really stuck out for me. I could relate so much to him; it sent chills up and down my spine. When he shared, he said, "If you want, I will give you my name and number after the meeting." After the meeting, we talked and I got his number. I had every intention to call him the next day, but I did not.

The rest of that week, I went to more meetings. At every one, they were talking about the importance of sponsorship. At only a couple of weeks sober, I did not know much of anything, but I did know I needed a sponsor. Despite understanding that, I still did not ask for one. You could say I was full of fear and ignorance.

The following Tuesday, I went to that same young people's meeting. Wouldn't you know, he was there. After the meeting, he came up to me. He asked why I did not call him. Right there, I just asked him to be my sponsor. I did not know it then, but I know it now: that was God doing for me, what I could not do for myself.

I remember it like it was yesterday. He said, "If I am going to be your sponsor, there are things you are going to have to do." He told me I had to go to a meeting every day, call him every day and read two pages out of the Big Book of Alcoholics Anonymous every day. I told him that would not be a problem.

He was my sponsor for exactly one year. In that year he taught me so much. He saved my life. We had a lot of meetings before the meeting and a lot of meetings after the meetings. That is where I really understood that for me, there is no bond like a bond with another drunk in recovery.
